In the course of business, a company enters into agreements with various parties, which can be another company, or a partnership firm, or a proprietorship concern, or even with an individual, etc. In order to sign and execute these agreements, a company official must have the necessary authorisation. Generally, the Managing Director or Whole-time Director (s) or Senior Executives are authorised to sign the agreements on behalf of the company, although any other employees can be authorised ...

This type of resolution is useful if a bank or other external organization ever requires verification to permit specific actions or powers, such as the authority to sign documents on behalf of the corporation.
